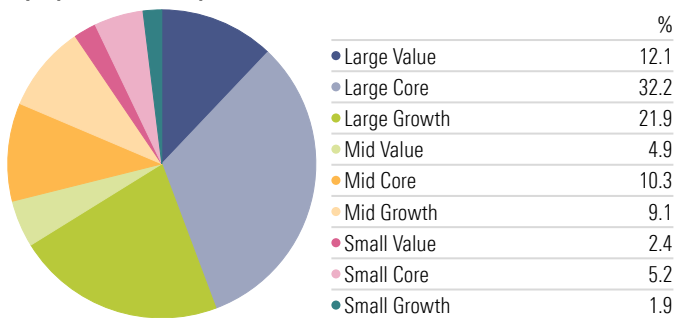

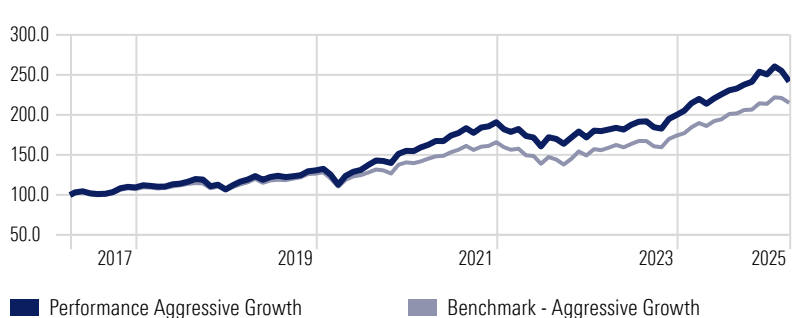
Equity Country Exposure

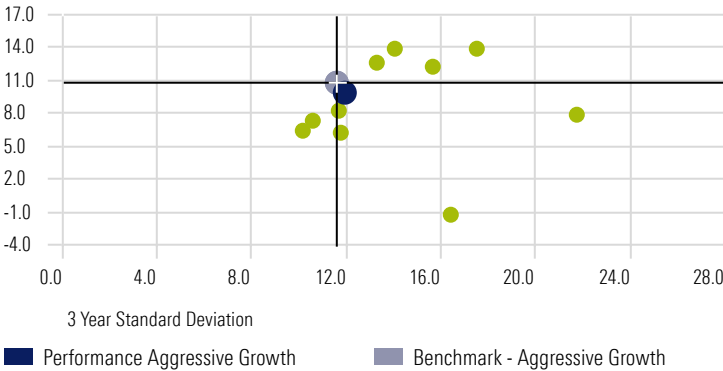

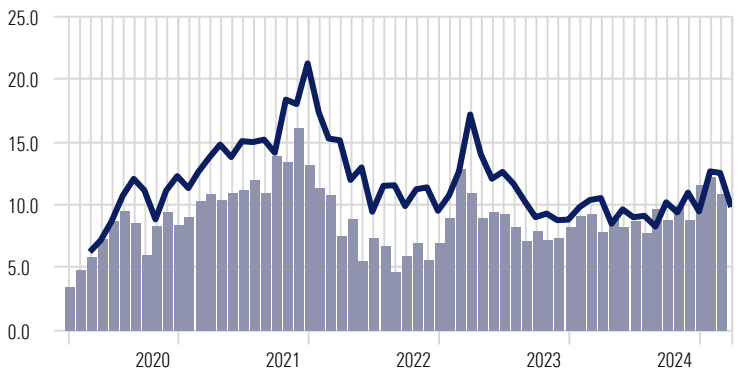
