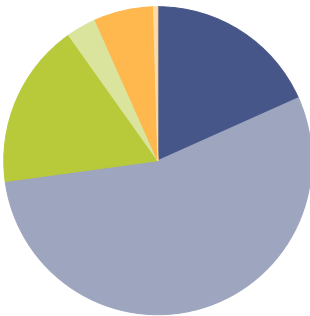

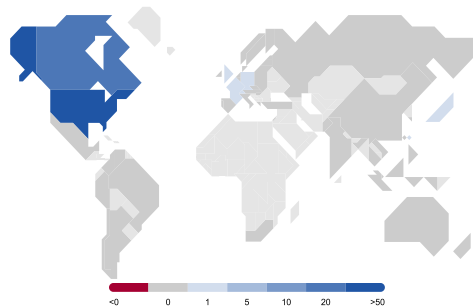

Asset Allocation



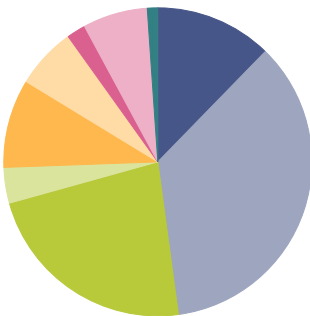

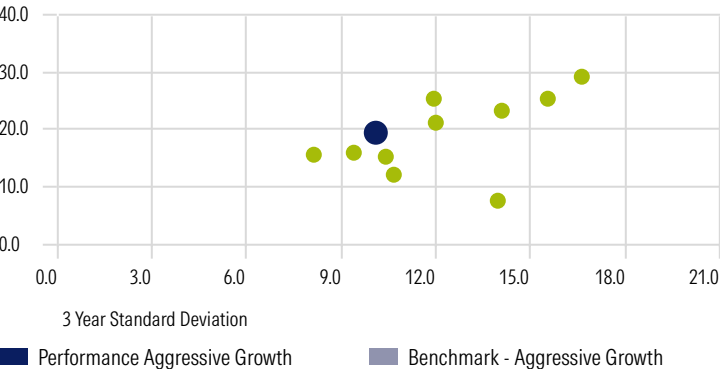

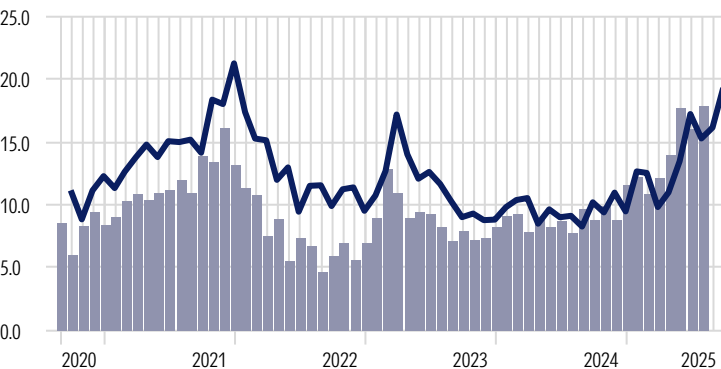
