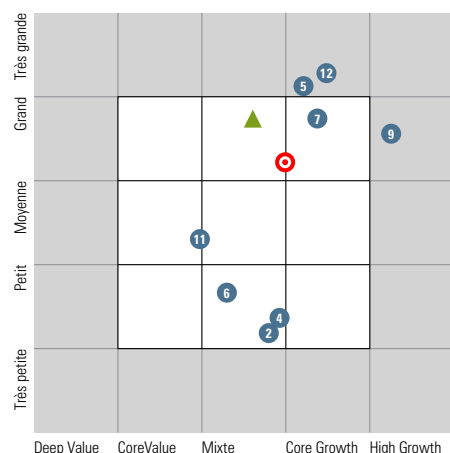

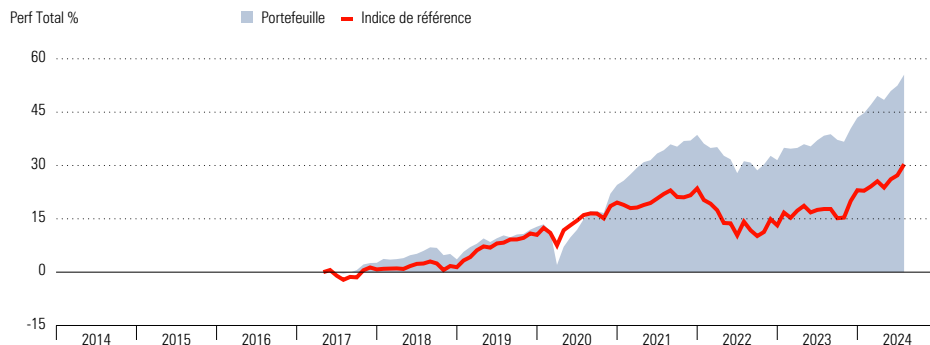

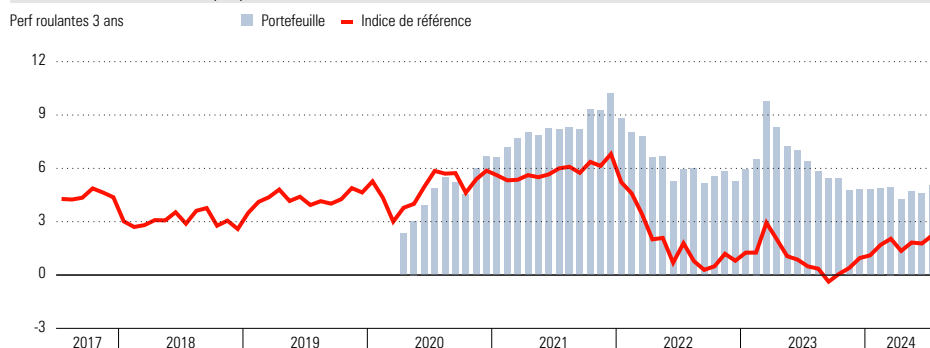

Rendement cumulé au 7/31/2024



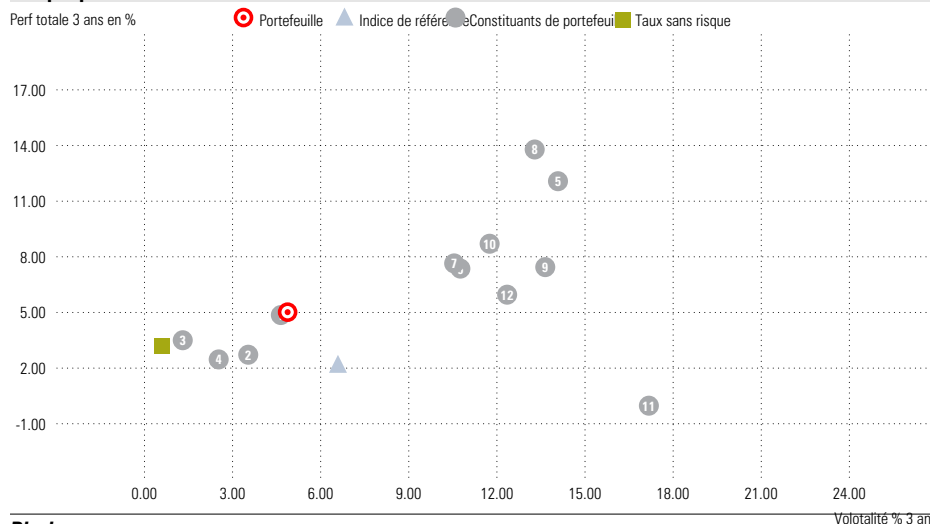
Rendement mobile au 7/31/2024
