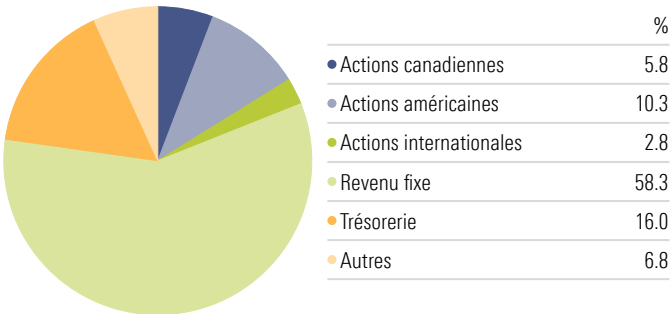

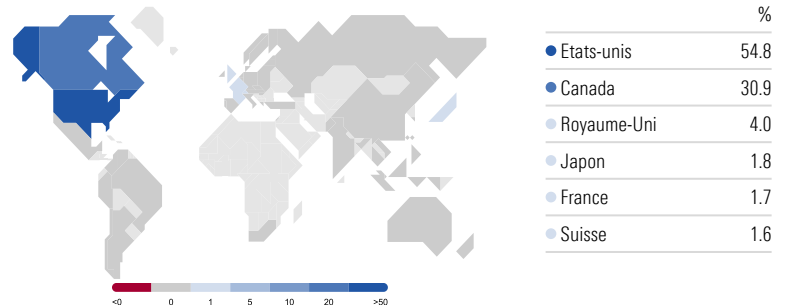

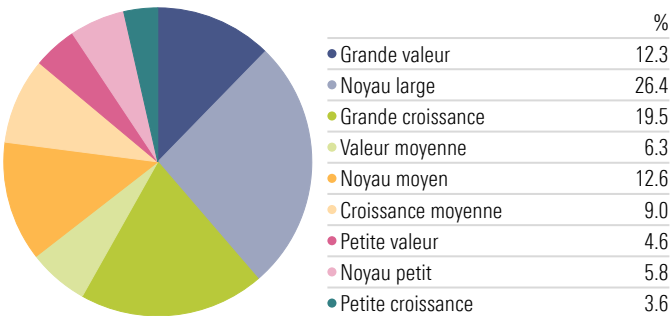
Répartition de l'actif



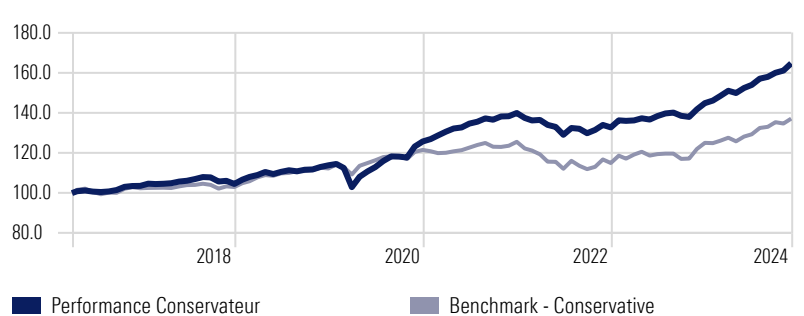

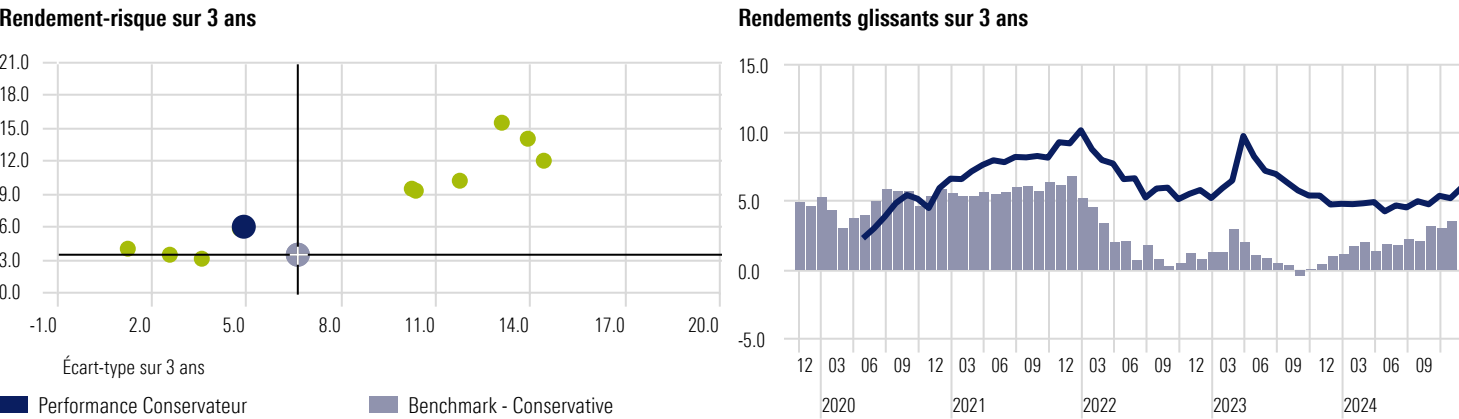

FTSE Canada Short Term Bond
