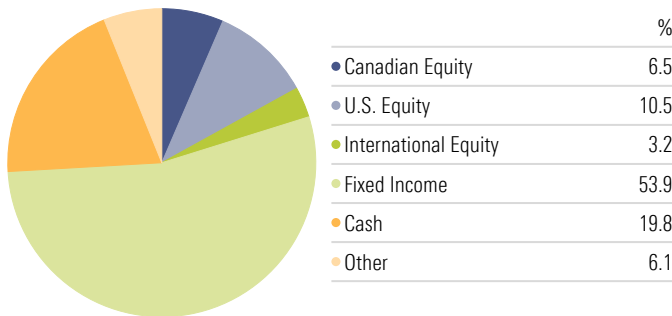

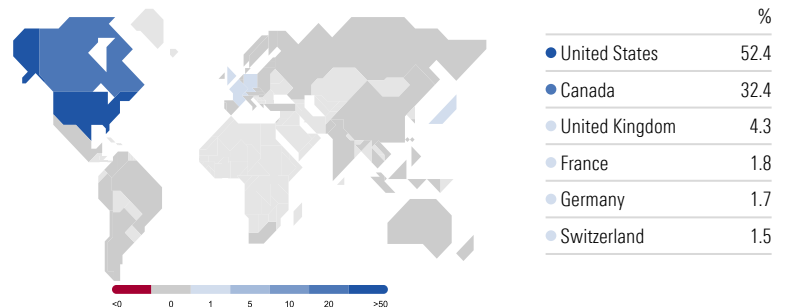

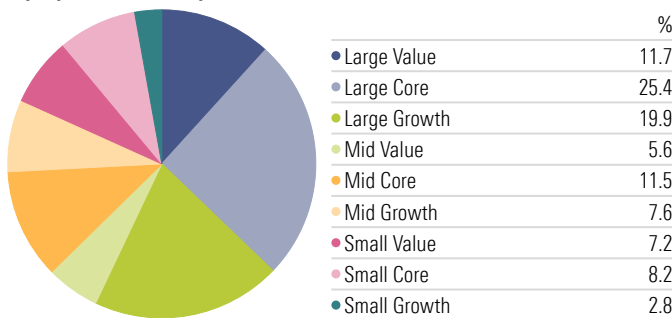
### Asset Allocation



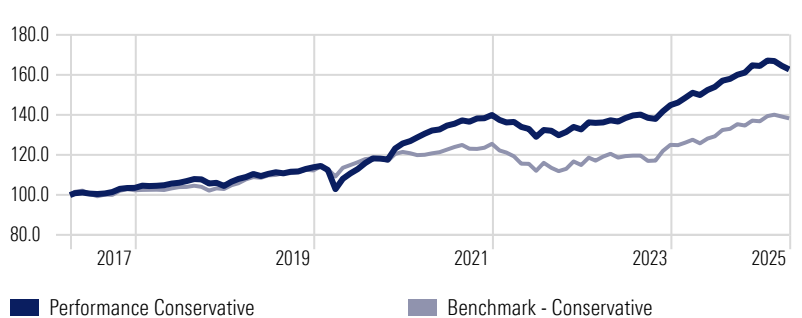

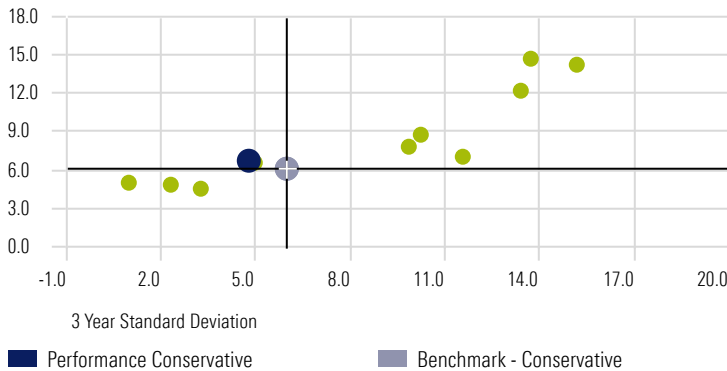

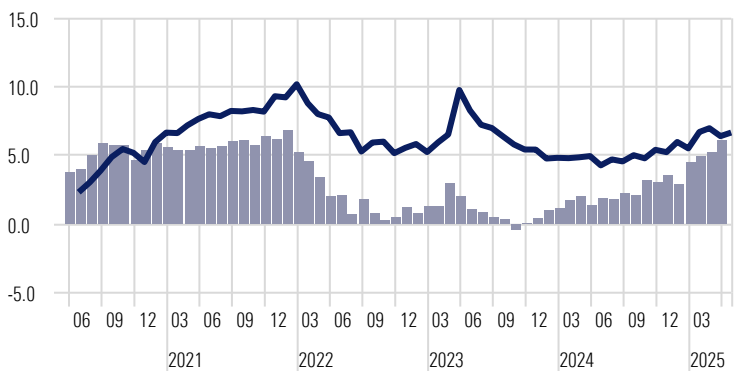
