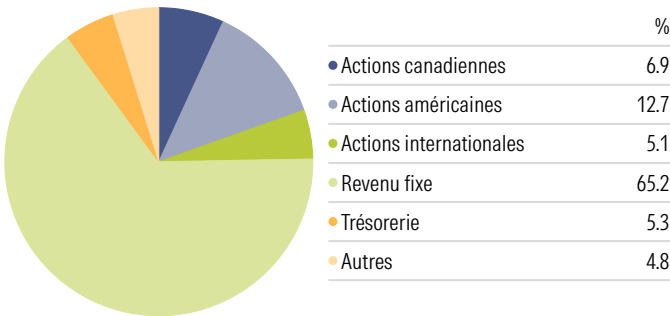

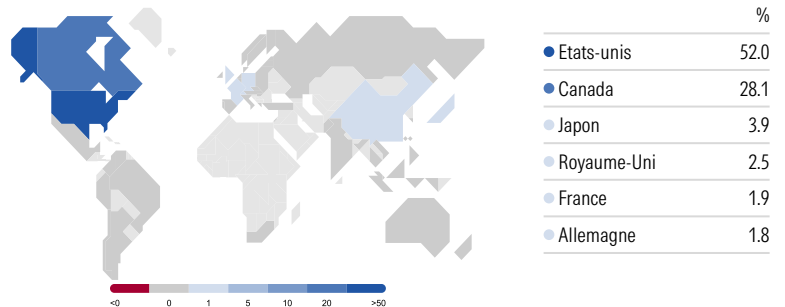

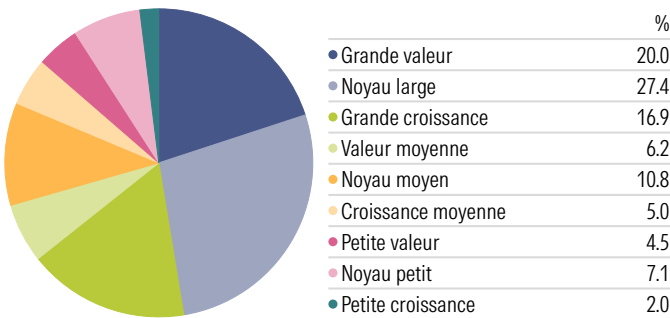
Répartition de l'actif



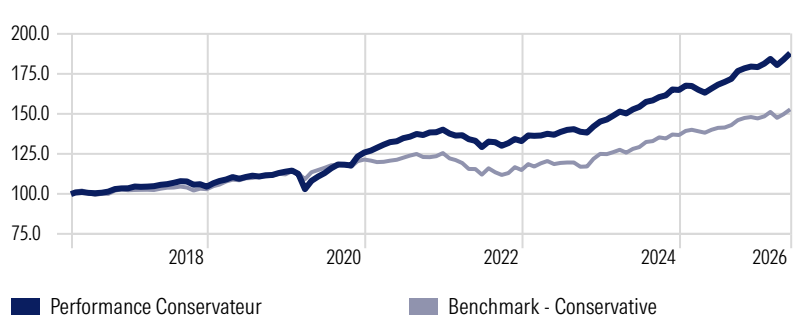
Exposition aux actions par pays

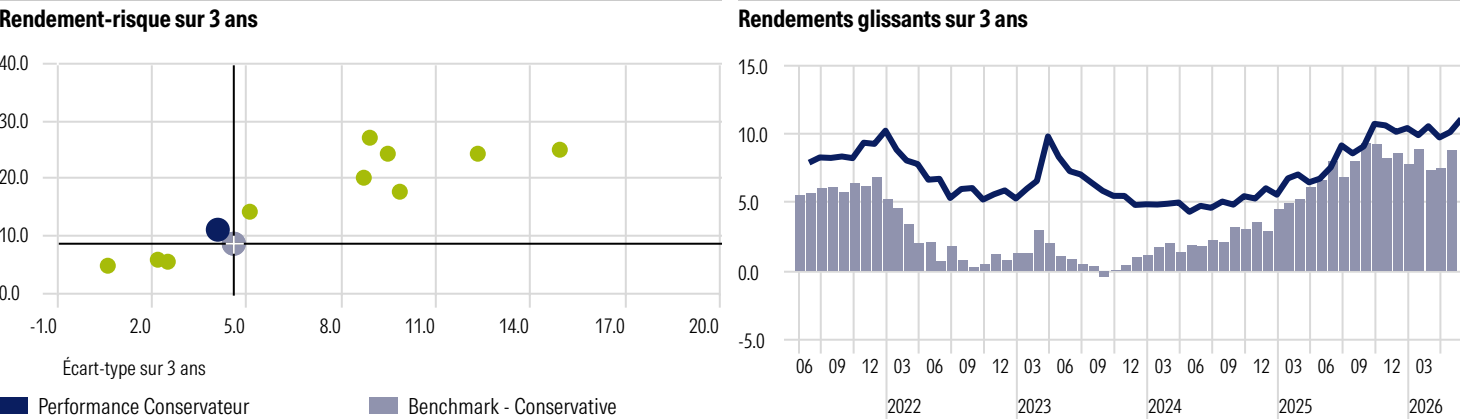

FTSE Canada Short Term Bond
