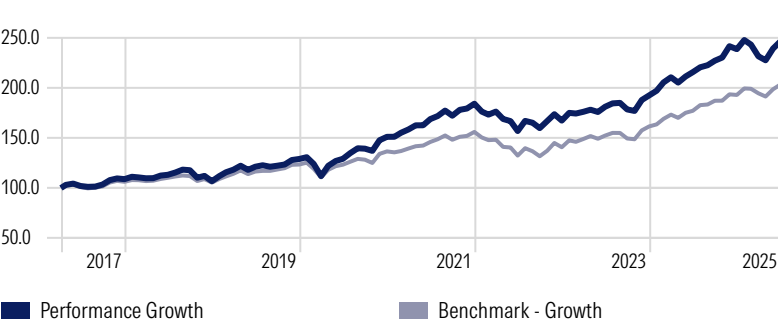
Equity Country Exposure

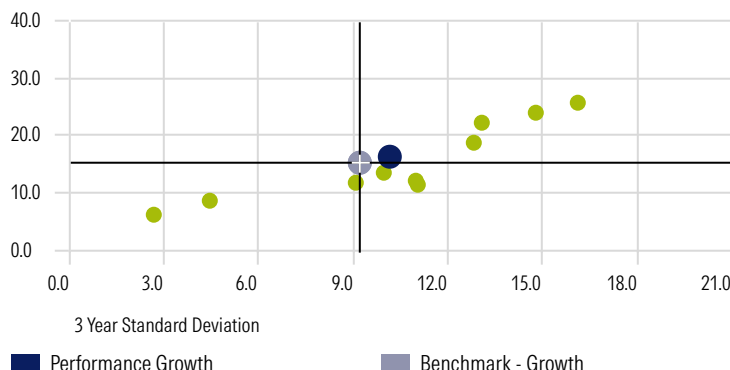

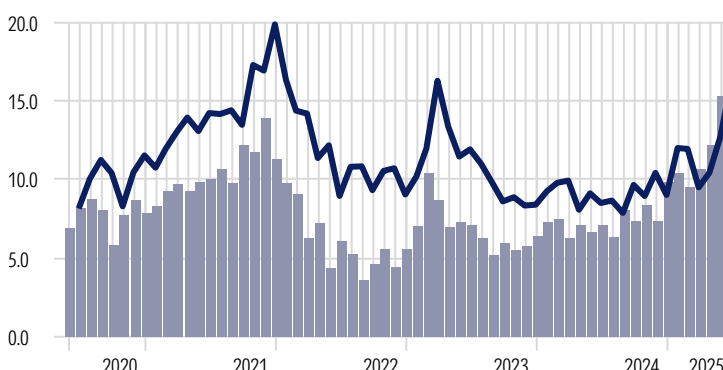
