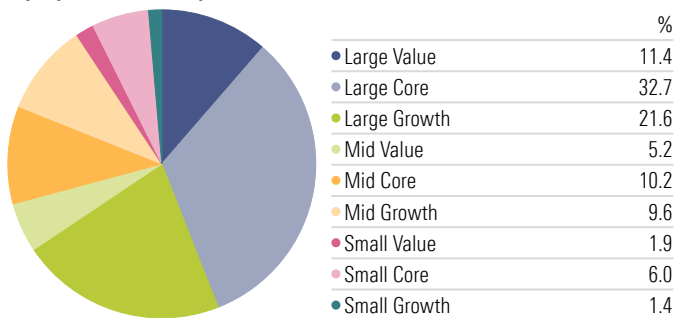

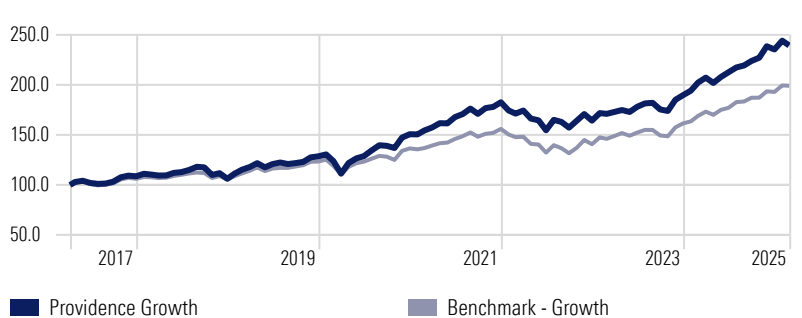

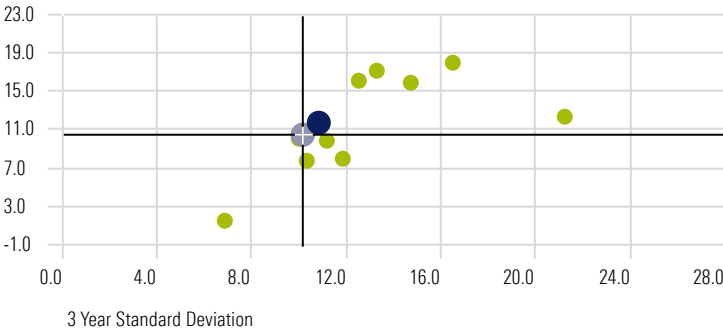

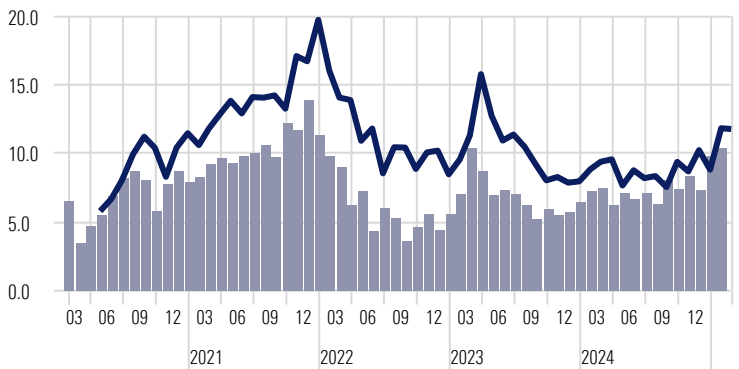
### 3 Year Risk-Reward
