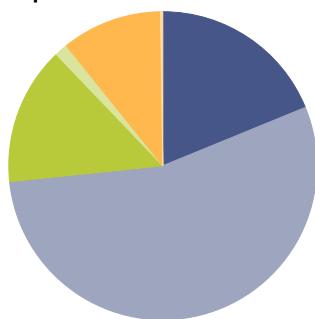

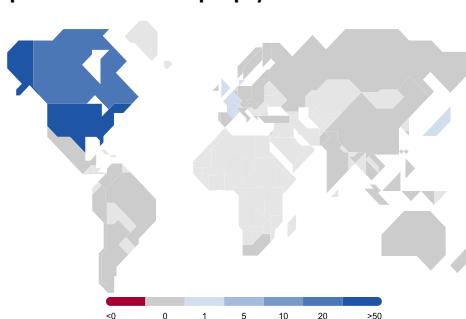

### Répartition de l'actif



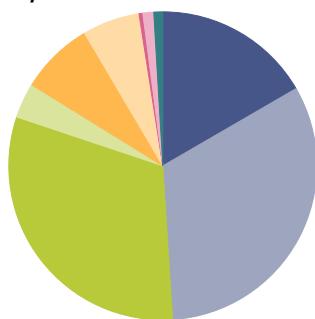

### Exposition aux actions par pays



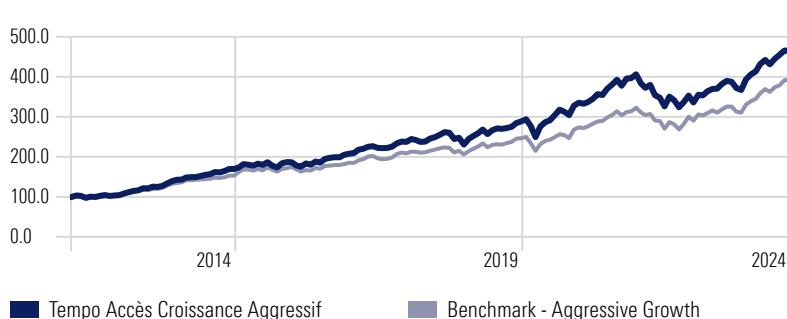

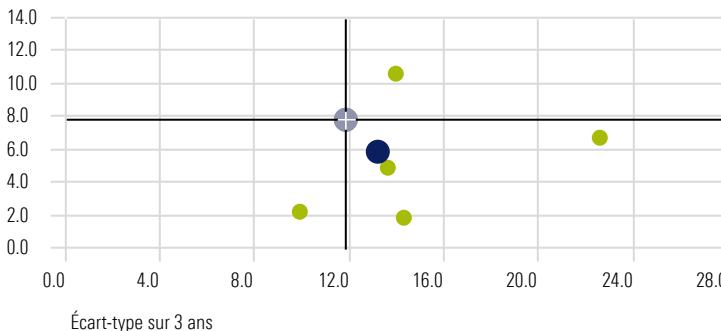
