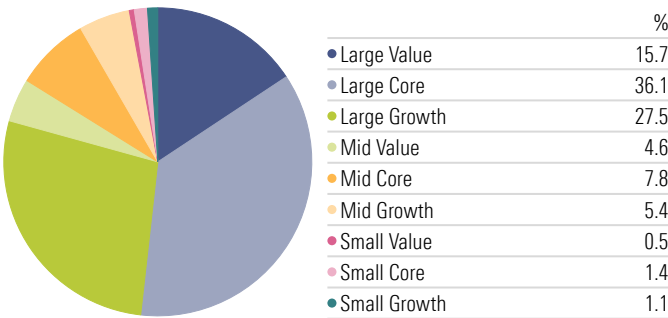

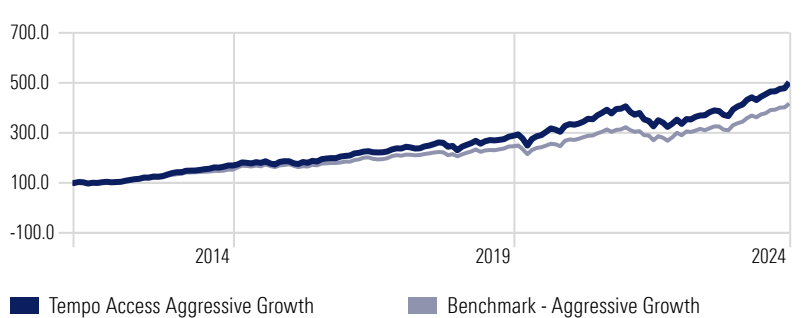
Equity Country Exposure

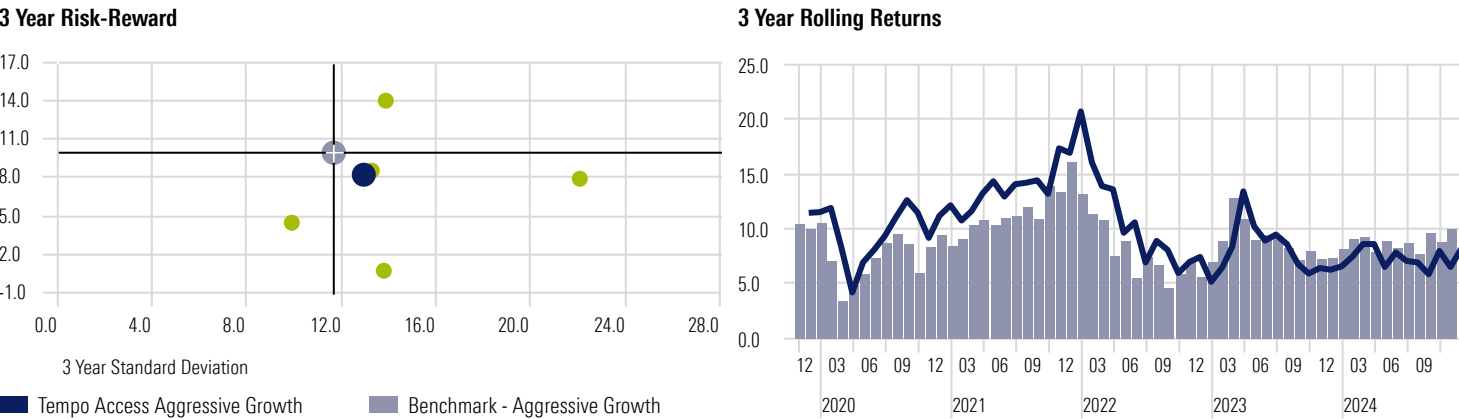
