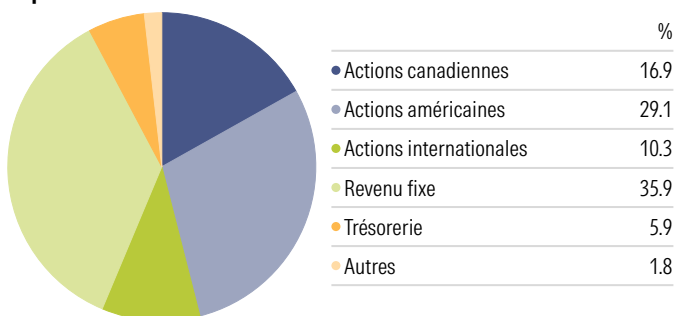

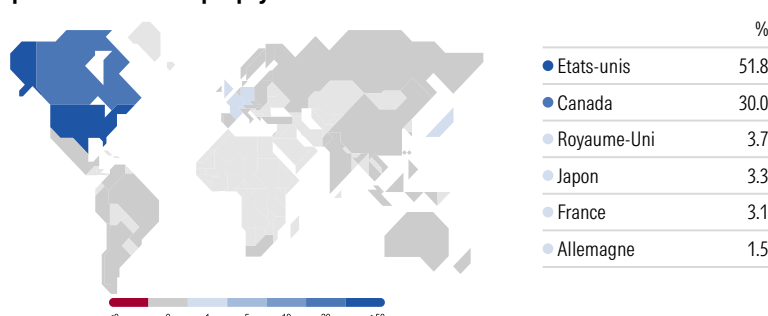

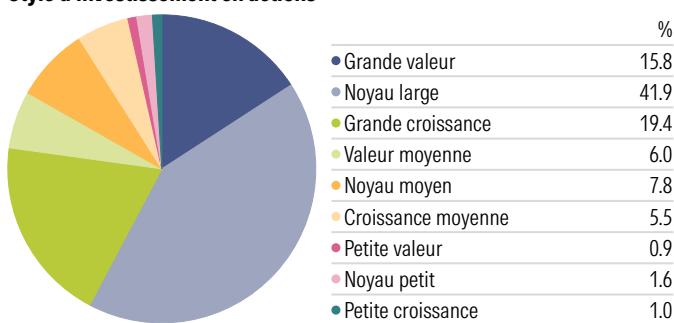

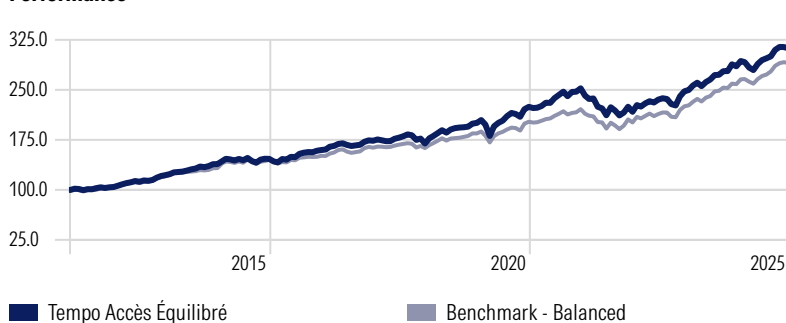
Exposition aux actions par pays

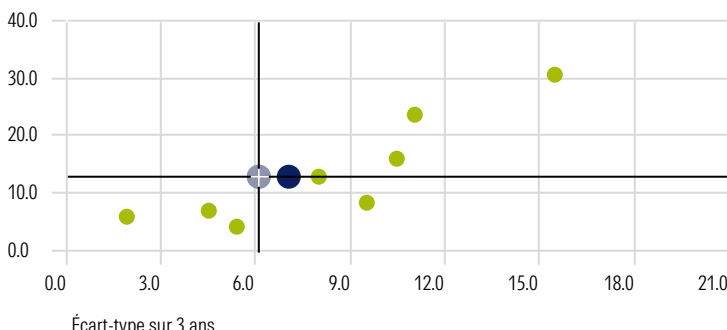

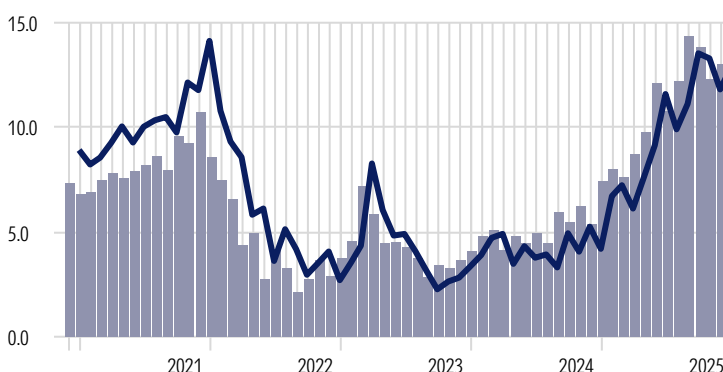
