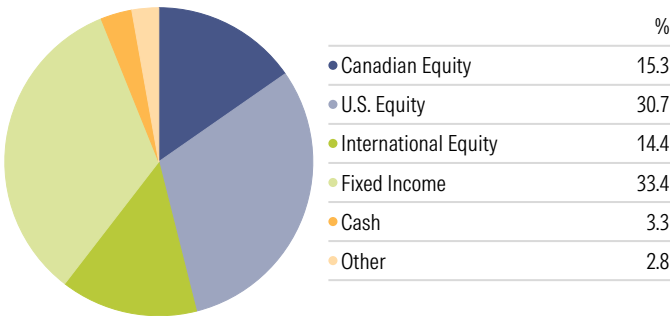

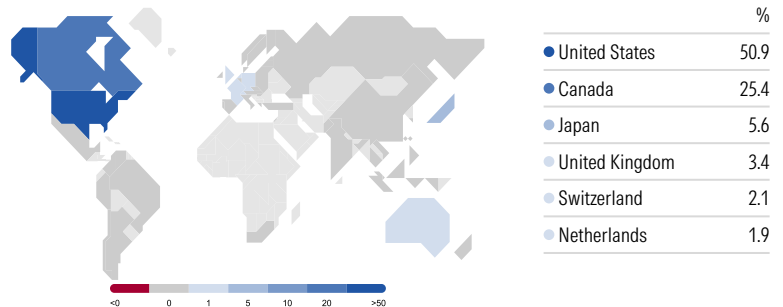

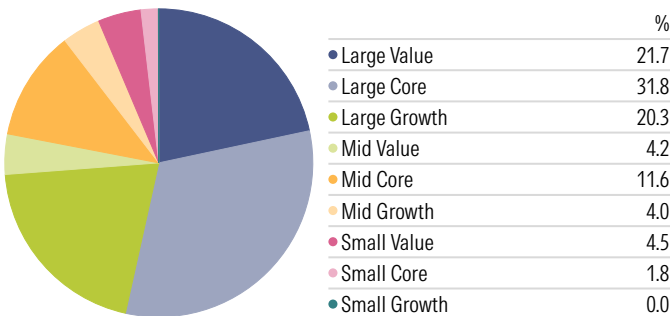

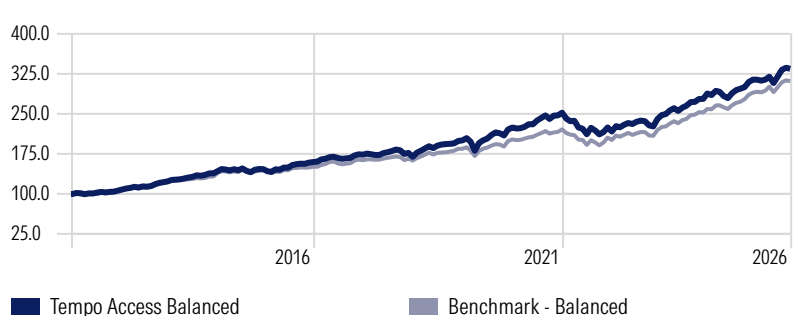
Equity Country Exposure

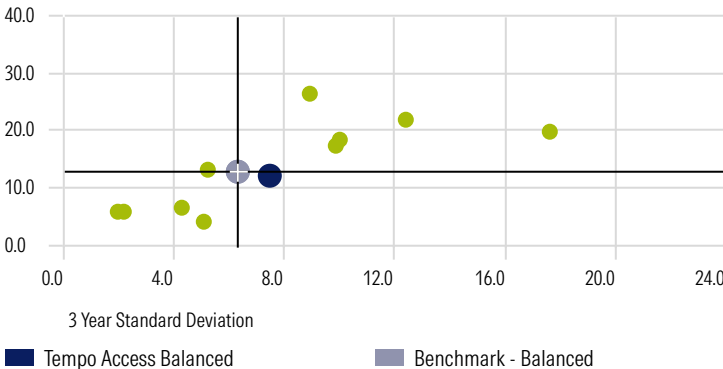

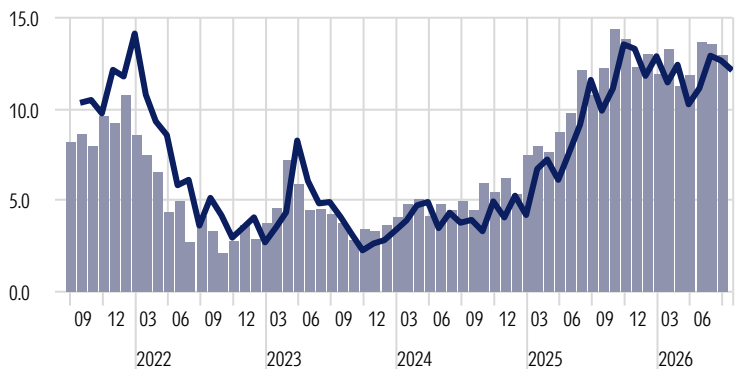
