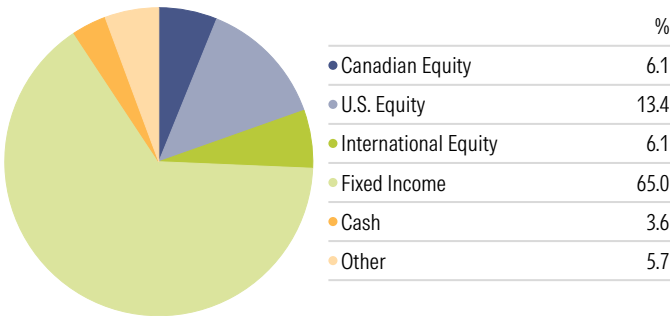

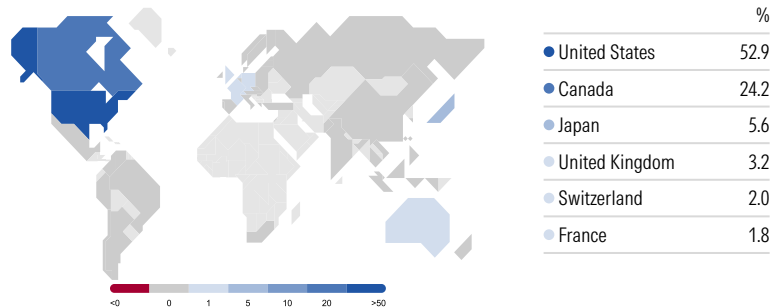

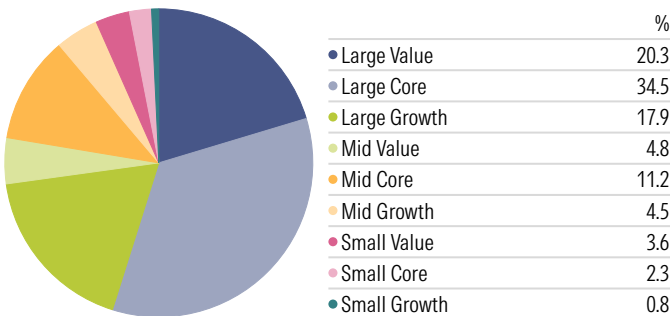
Asset Allocation



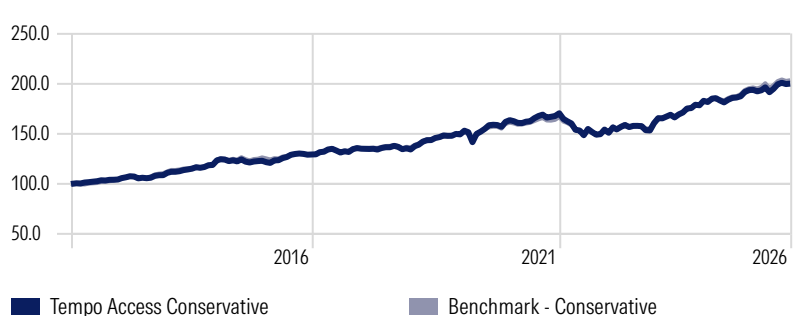
Equity Country Exposure

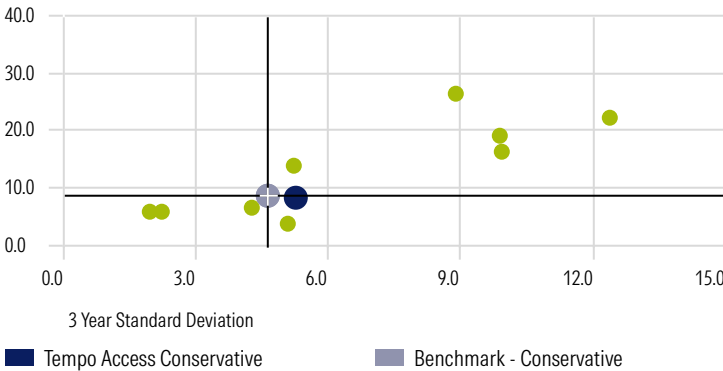

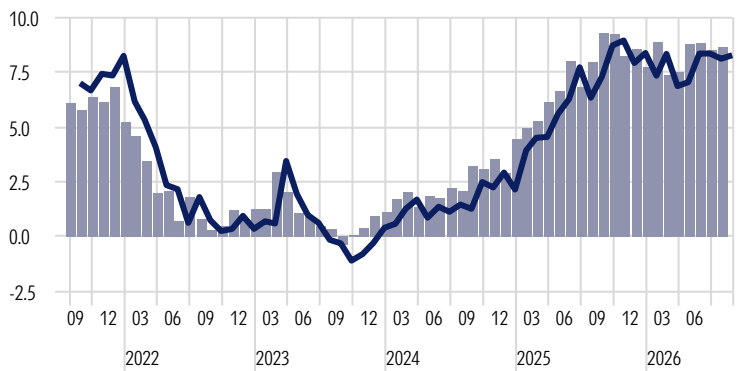
