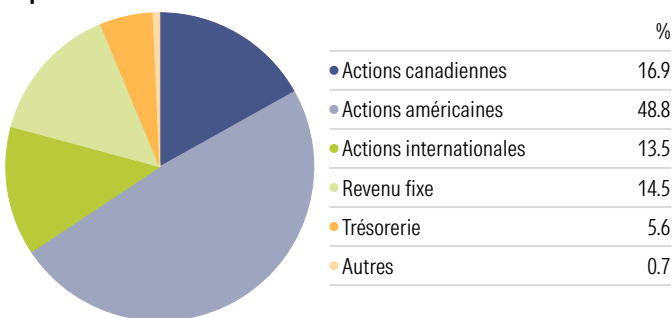

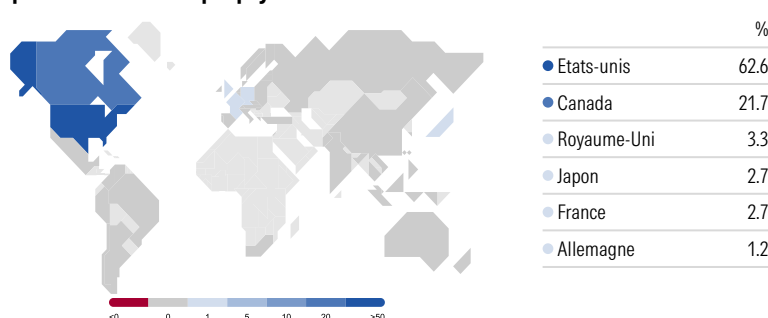

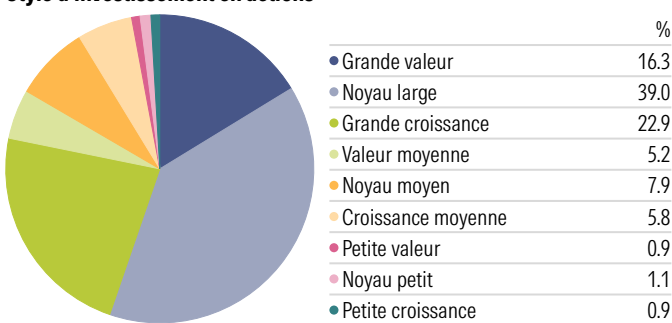
### Répartition de l'actif



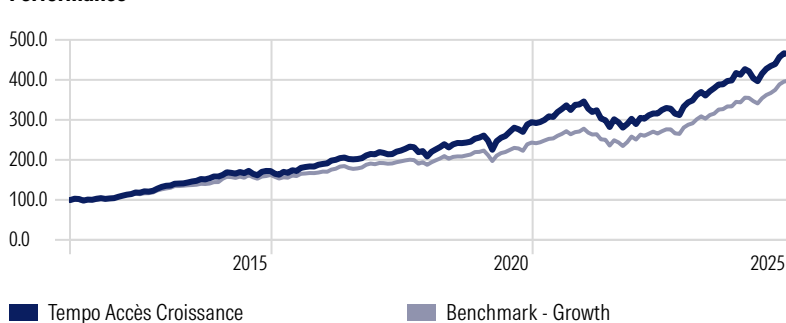

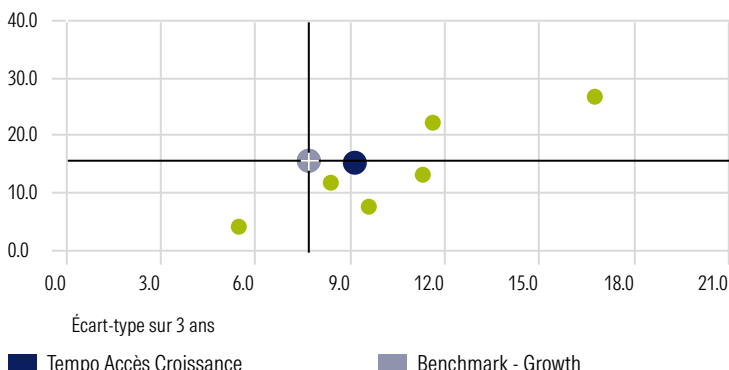

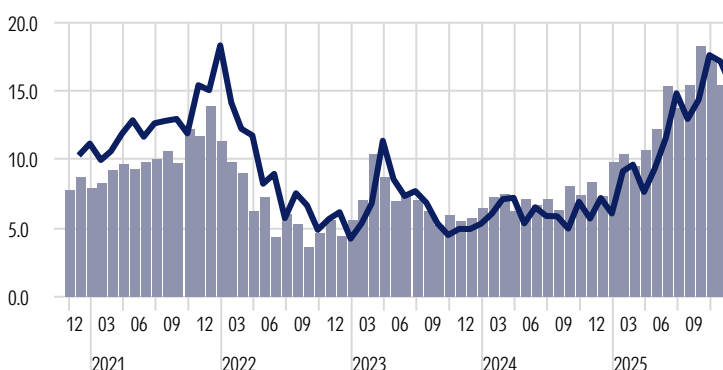
