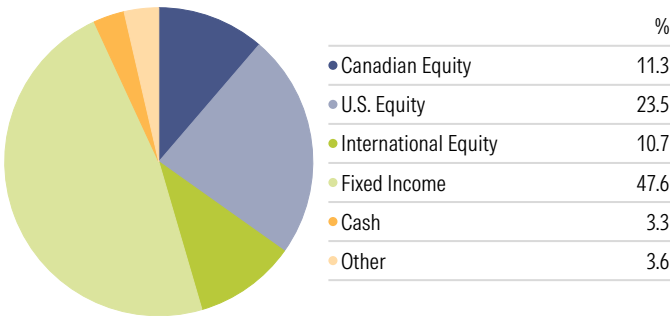

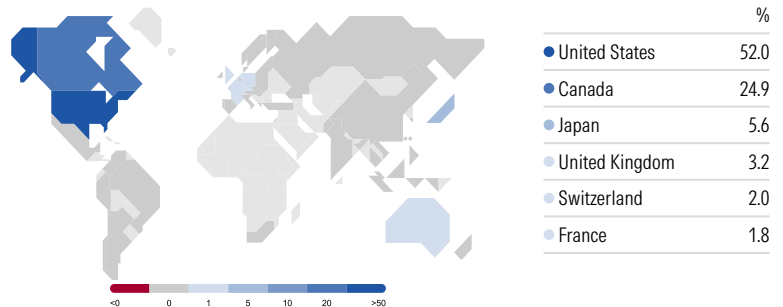

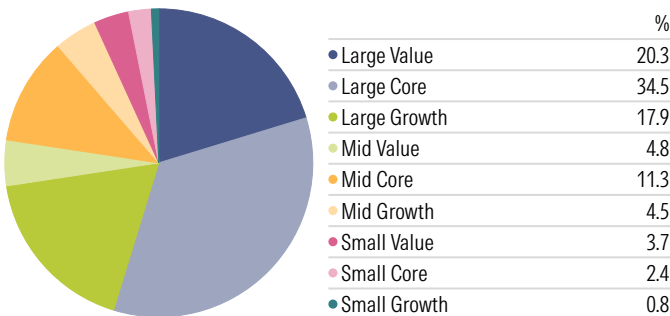

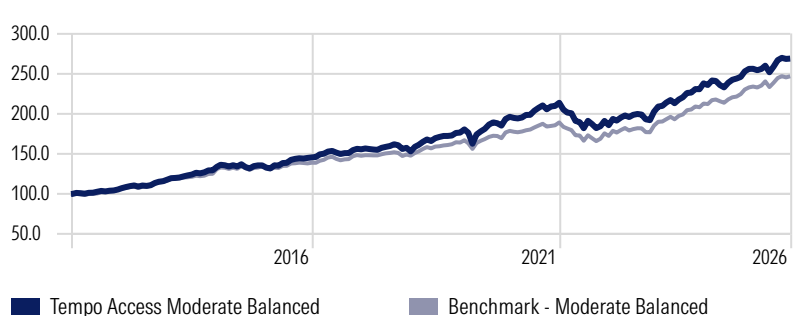
Equity Country Exposure

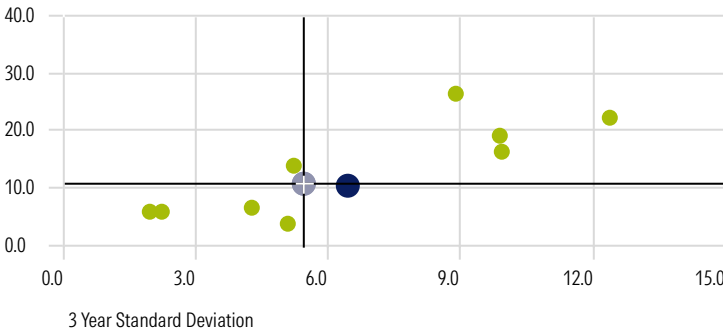

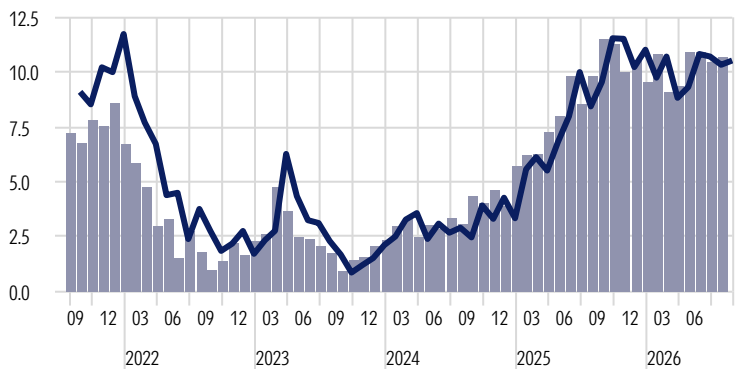
3 Year Risk-Reward
