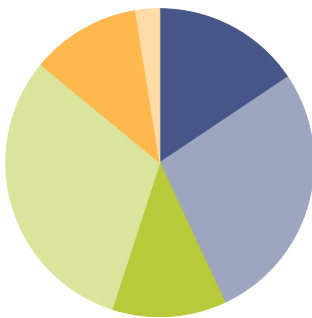

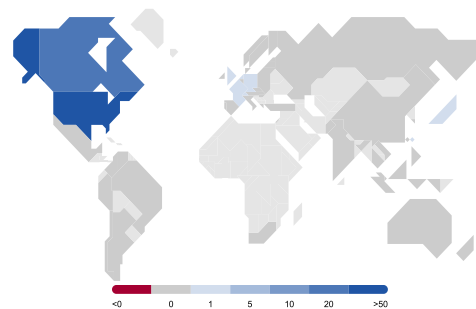

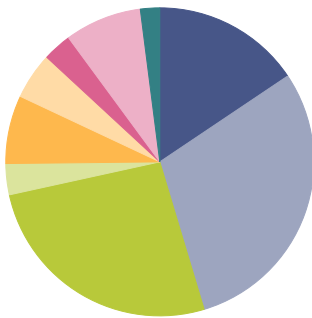

### Equity Country Exposure



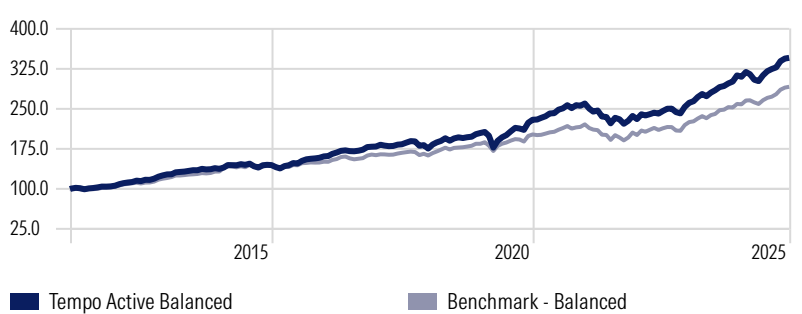

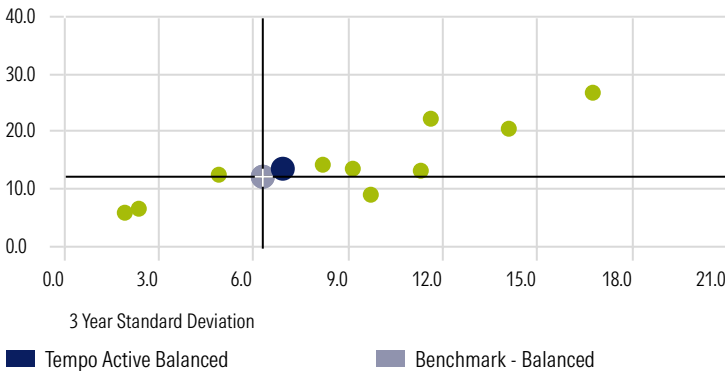

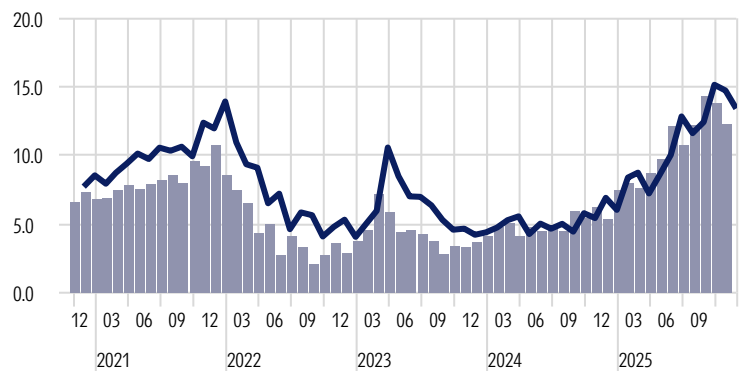
