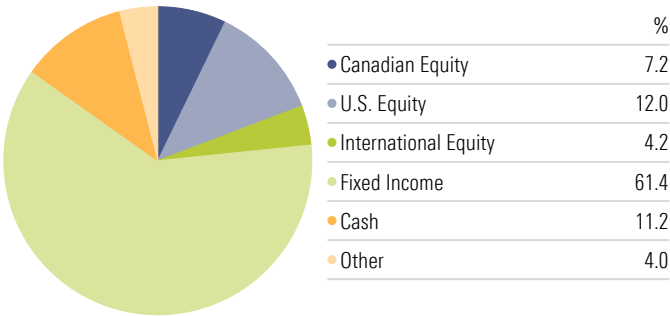

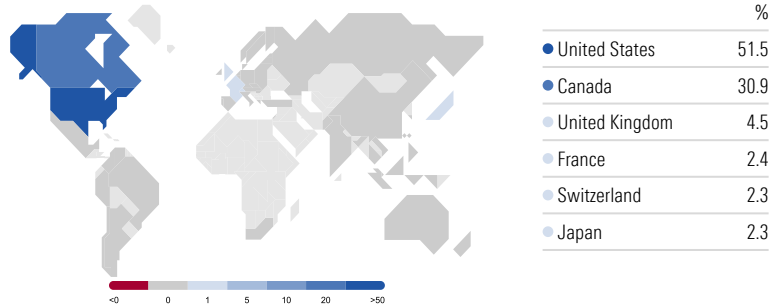

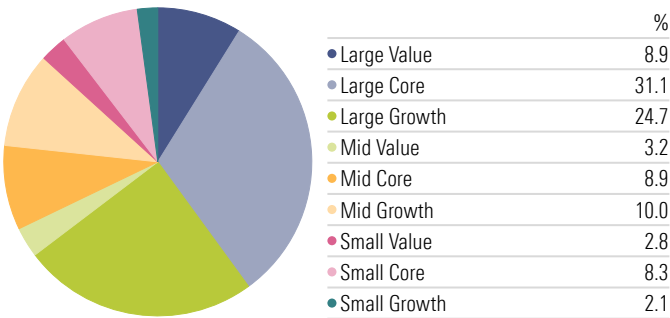
Asset Allocation



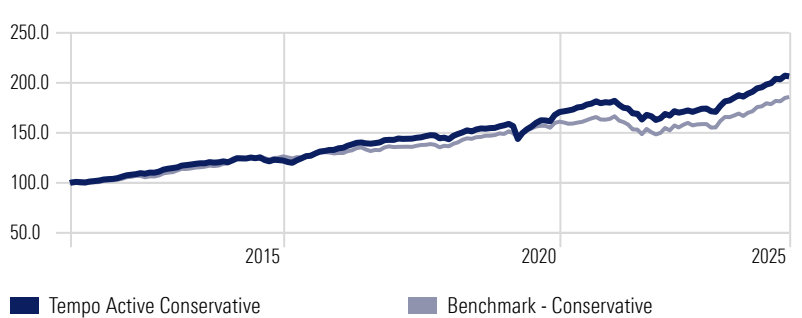
Equity Country Exposure

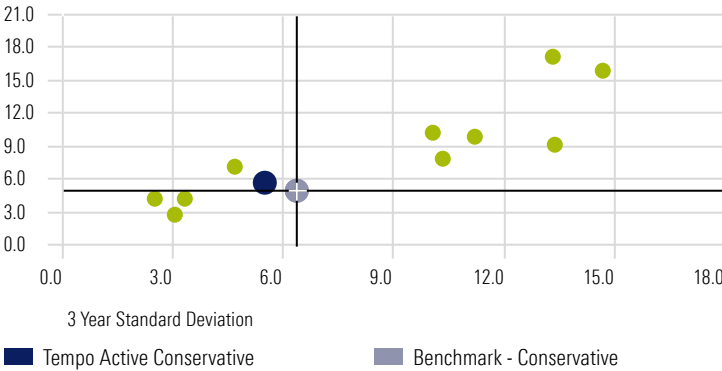

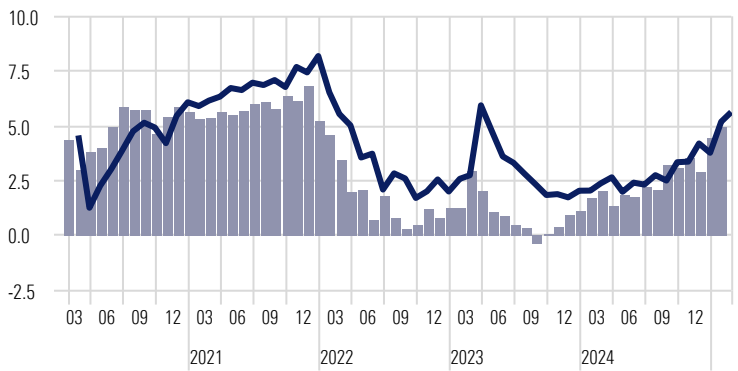

FTSE Canada Short Term Bond

FTSE Canada Universe Bond
