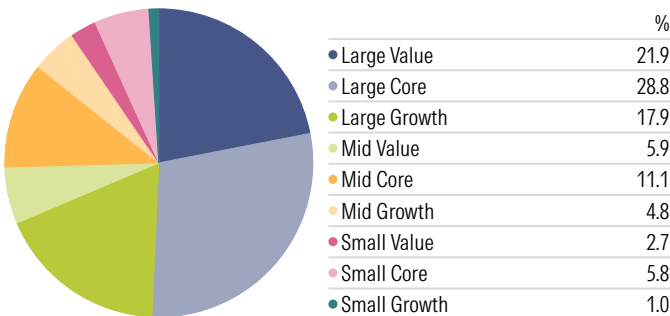

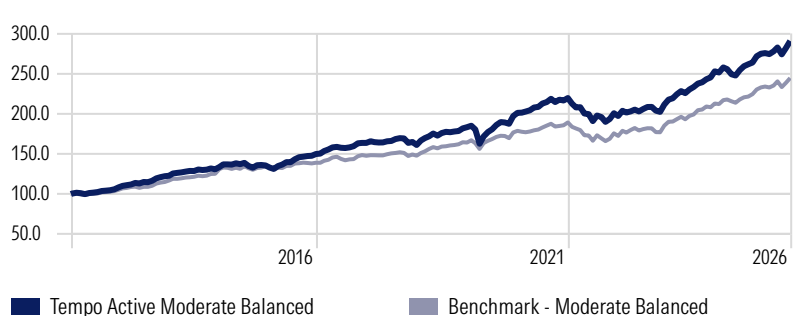
Equity Country Exposure

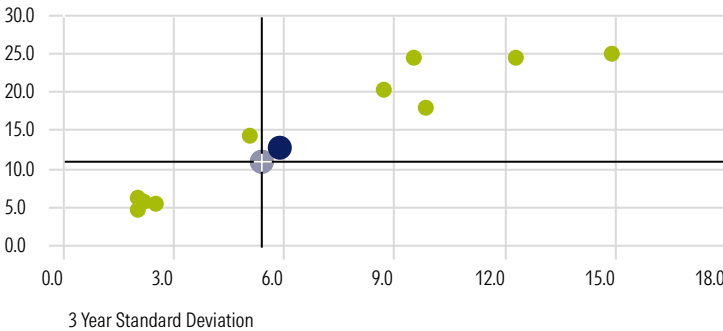

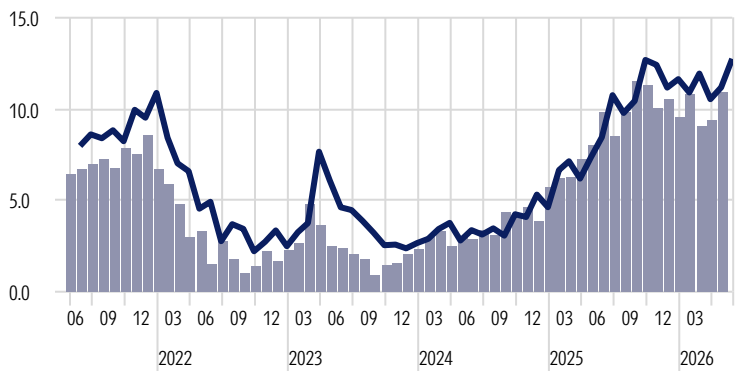
3 Year Risk-Reward

FTSE Canada Short Term Bond

FTSE Canada Universe Bond
