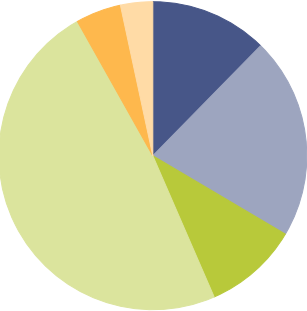

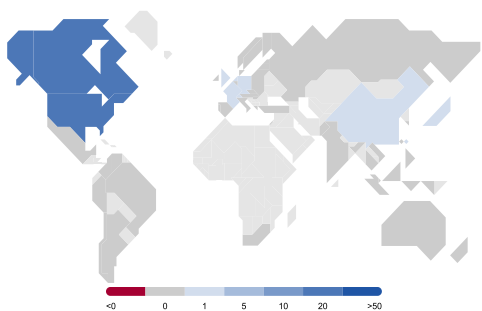

### Exposition aux actions par pays



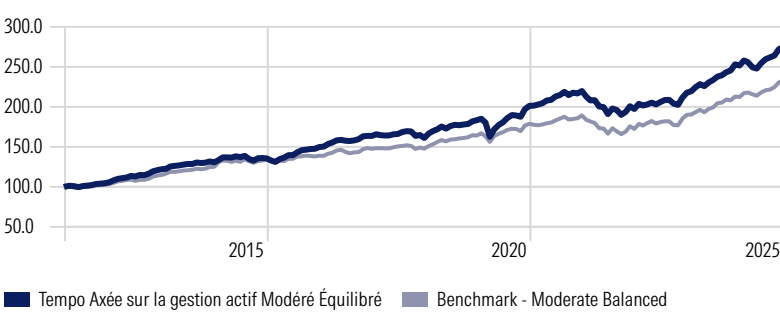

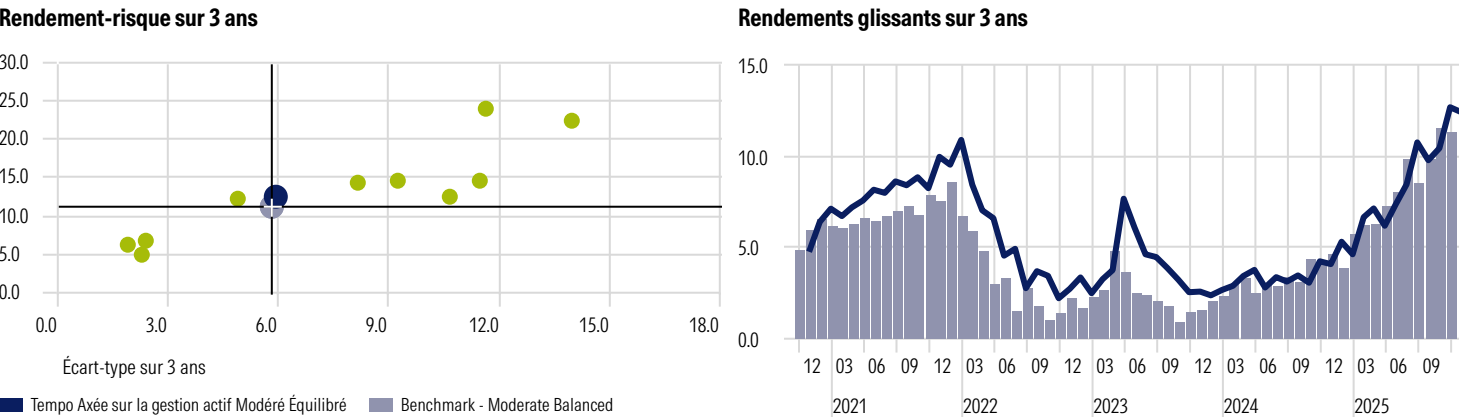
