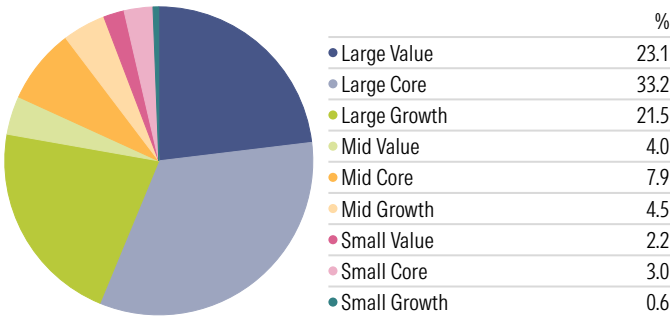

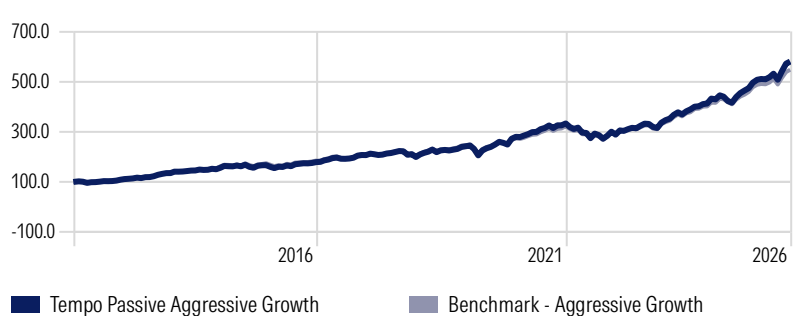
Equity Country Exposure

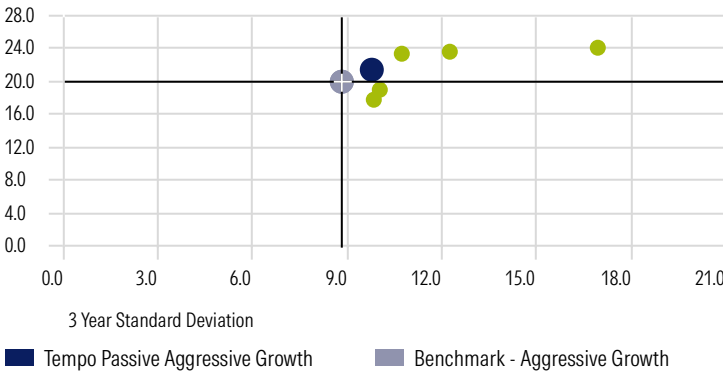

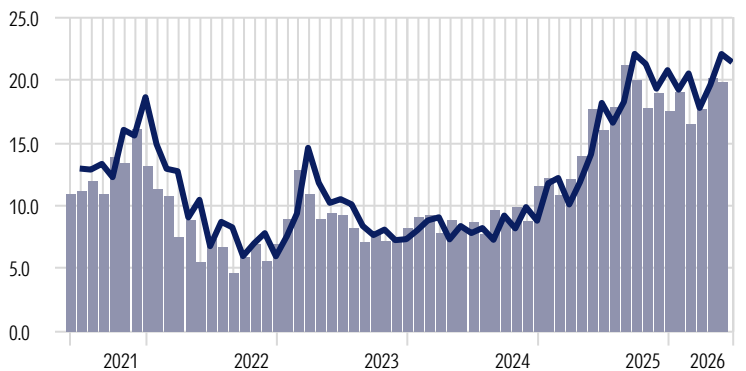

Benchmark Disclosure

FTSE Canada Short Term Bond

FTSE Canada Universe Bond

Morningstar Developed Markets xNA NR CAD
