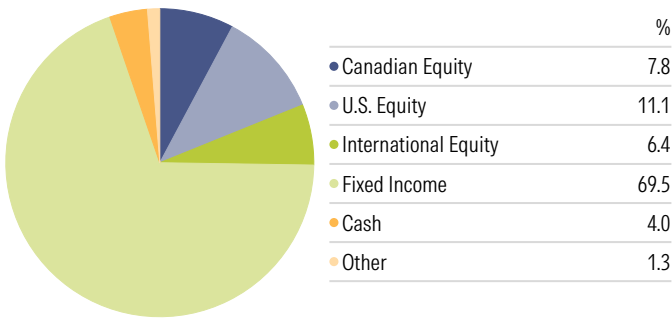

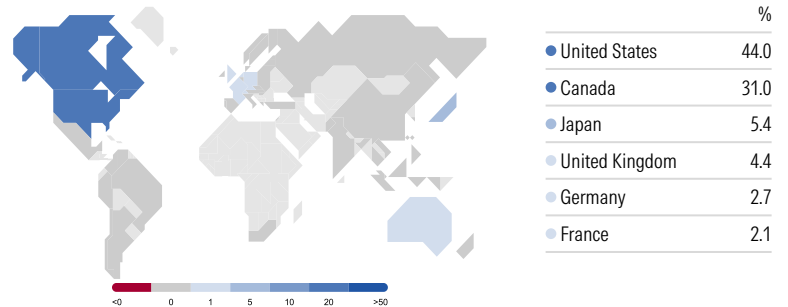

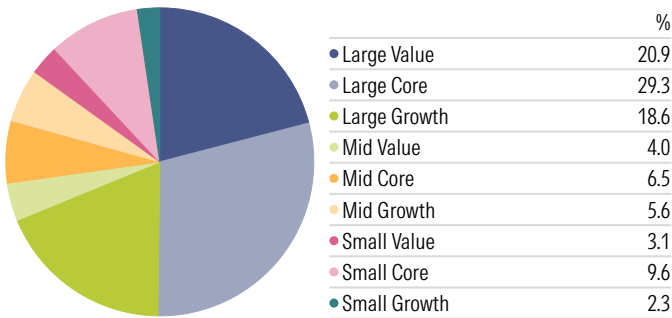
Asset Allocation



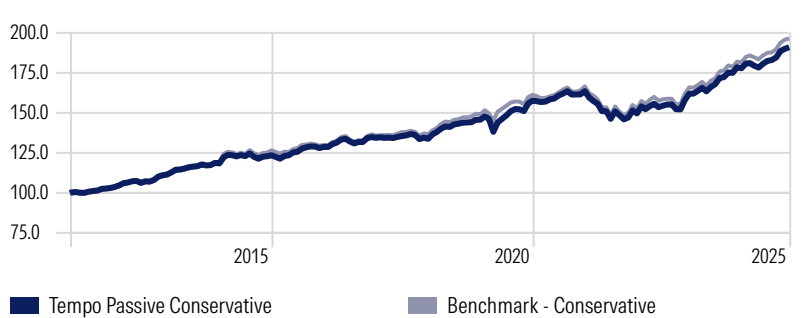
Equity Country Exposure

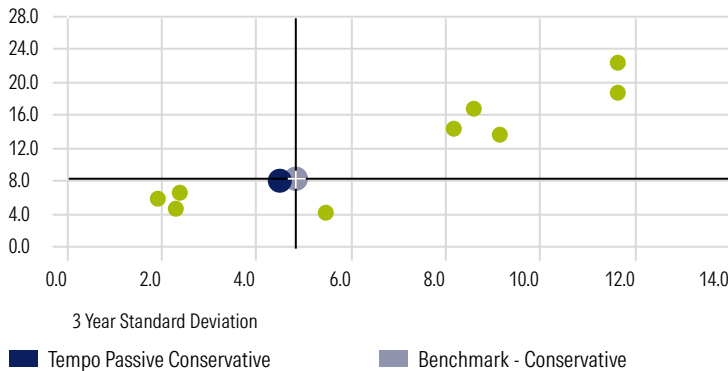

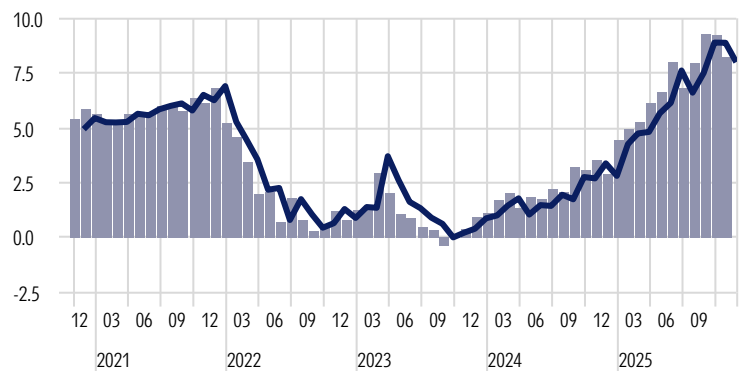

Benchmark Disclosure

FTSE Canada Short Term Bond

FTSE Canada Universe Bond
