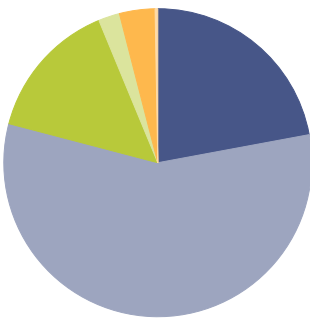

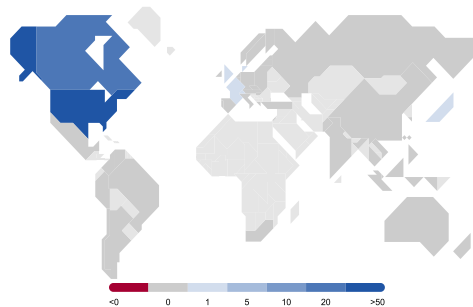

Asset Allocation



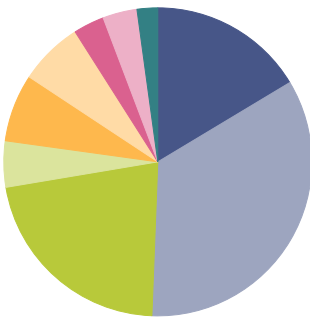

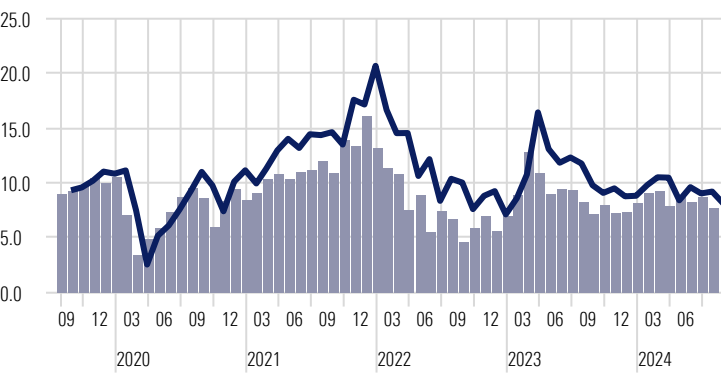

Benchmark Disclosure

FTSE Canada Short Term Bond
