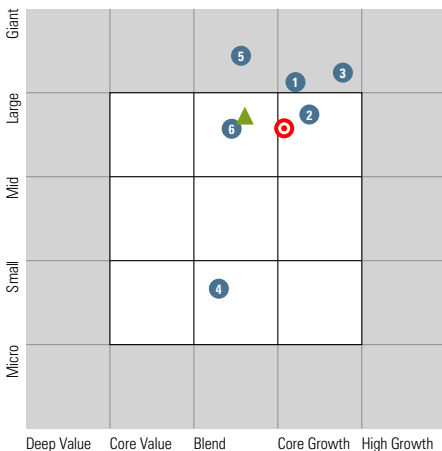

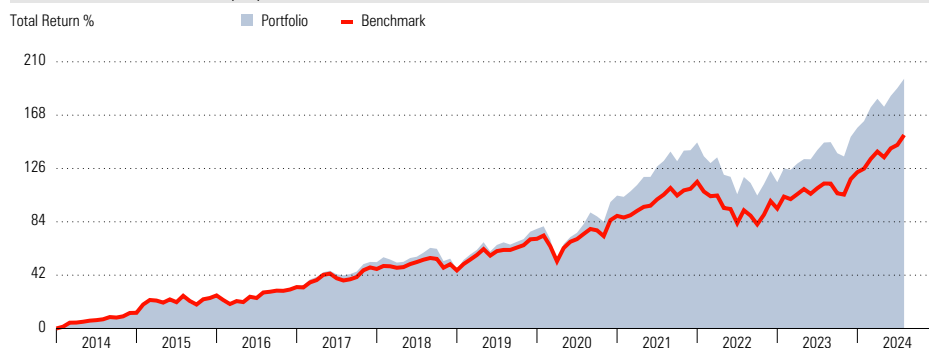

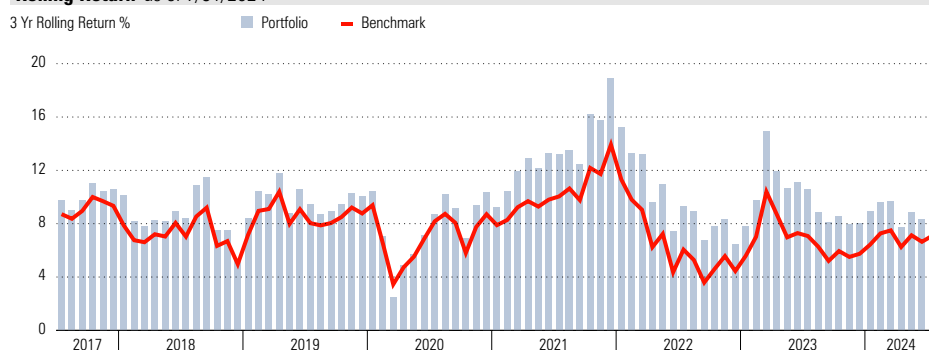
Cumulative Return as of 7/31/2024

Rolling Return as of 7/31/2024



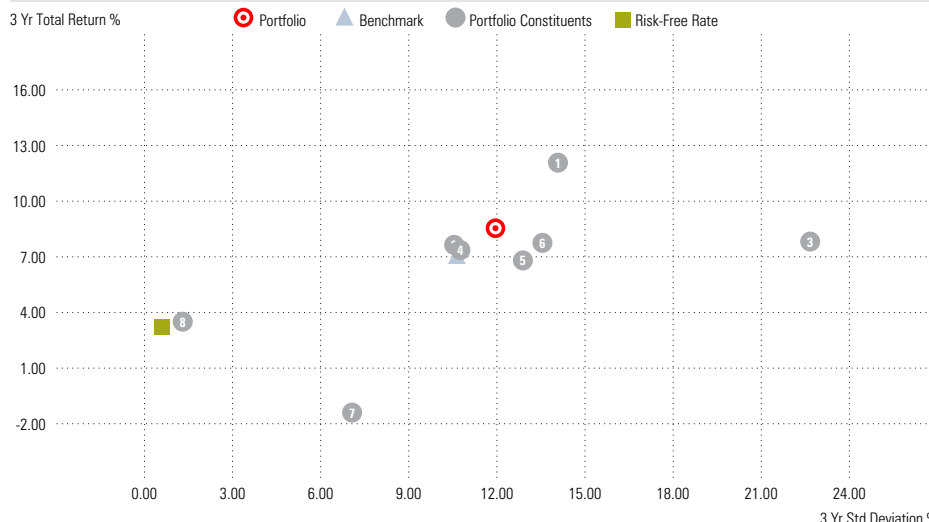
