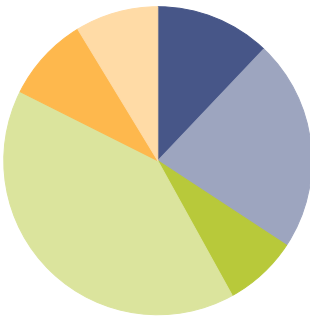

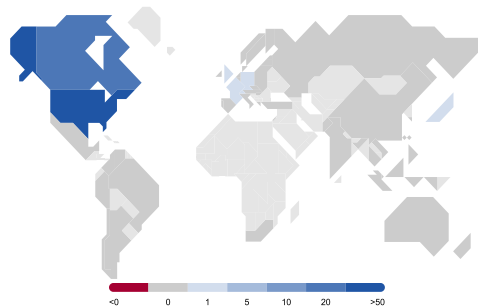

Asset Allocation



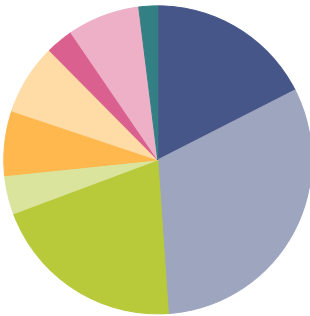

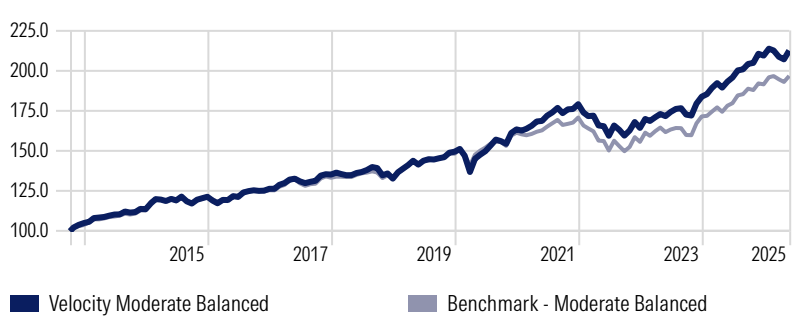

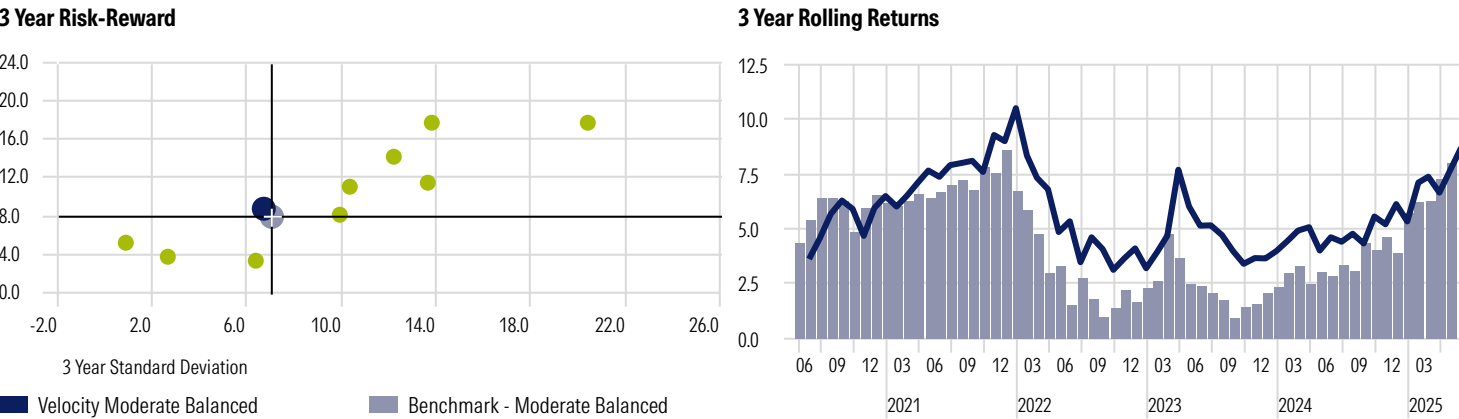

FTSE Canada Short Term Bond
